CMA Ryu Liability Student Waiver

- 1. I, the undersigned, am at least 18yrs old and desire to participate in the martial arts classes run by CMA Ryu (Combat Martial Arts School). I have been made aware that the class will include hands on training, close quarter and contact training, training with specific training weapons, ground holds and groundwork and that such training carries a risk of injury or impairment to my body, general health, wellbeing and could also include serious injury.
- 2. Knowing the hazards and risks involved I, on behalf of myself, my family, spouse, heirs and personal representative(s) (the Releasors), agree to assume all the risks and responsibilities surrounding my participation in the class and any associated training such as seminars or workshops held by CMA Ryu, their parent association the IKJJU (the International Kempo Ju-Jitsu Union) and other member clubs. On behalf of myself and the Releasors I hereby agree not to pursue any legal action or claim against CMA Ryu, the IKJJU, their trustees, officers and representatives (Releasees) and I hereby release, waive, forever discharge the Releasees from and against any and all liability for any harm, injury, damage, claims, demands, actions, causes of actions, costs and expenses of any nature that I may have or that may hereafter accrue to me or a Releasor arising out of, or relating to participation in the class or other training activities. It is my expressed intent that this Liability Release and Waiver shall bind me, the members of my family and spouse, if I am alive, and my estate, family, heirs, spouse, administrators, personal representatives, or assigns if I am deceased, and shall be deemed as a legally binding release, waiver, discharge and covenant not to sue the Releasees.
- 3. I agree to conduct myself in accordance with the rules of conduct and standards of behaviour that are expected of me as a student of CMA Ryu and the Martial Arts in general, and to abide by the various instructions and guidance I am provided with by the designated Sensei, Instructor or Coach of CMA Ryu and the IKJJU.
- 4. I do not suffer from any physical or mental condition that would limit my ability to participate in the activities of the class. I understand, agree and hereby grant the Releasees permission to authorise any emergency medical treatment for me, if necessary, that may arise due to participation in the activities of the class and that any and all such actions by the Releasees shall be subject to the terms of this agreement. I understand and agree that the Releasees assume no responsibility for any injury or damage which might arise out of or in connection with such authorised emergency medical treatment.

This is a legal agreement and includes a release of legal rights. Read thoroughly and ensure that you fully understand it before signing.
